Q. Provide a table showing the annual dollar and percentage distribution of Newfoundland Power's cost of service according to the five main categories: purchased power, operating expenses, return on rate base, income taxes, and depreciation. The table should cover the years 1992 to 2002.

A. Table 1 below provides the annual dollar and percentage distribution of Newfoundland Power's cost of service according to the five main categories: purchased power, operating expenses (excluding non-regulated expenses), depreciation, income taxes (excluding the income tax effects of non-regulated expenses), and return on rate base for the years 1992 to < > 2002.
