- 1 IN THE MATTER OF the Automobile 2 Insurance Act, RSNL 1990, c. A-22, 3 as amended and regulations 4 thereunder; and 5 6 **IN THE MATTER OF** an application by 7 Aviva General Insurance Company for 8 approval to implement a revised rating 9 program for its Interurban Vehicles 10 category of automobile insurance. 11 12 13 WHEREAS on December 1, 2023 Aviva General Insurance Company ("Aviva") applied to the Board 14 for approval of a revised rating program under the Mandatory Simplified filing option for its 15 Interurban Vehicles category of automobile insurance; and 16 17 **WHEREAS** Aviva proposed the following rating program changes resulting in an overall rate level 18 impact of +11.7%: 19 20 i) introduction of DCPD deductibles; 21 ii) changes to discounts and surcharges; 22 iii) changes to endorsements; and 23 iv) changes to rating and underwriting rules; and 24 25 WHEREAS Aviva did not perform an actuarial analysis due to its limited exposure count and lack 26 of credible data for this type of business; and 27 WHEREAS on February 13, 2024 Aviva filed an amendment to withdraw its proposed 28 29 endorsement changes; and 30 31 WHEREAS on February 23, 2024 Aviva filed a further amendment to withdraw a proposed 32 underwriting rule change; and 33
- 34 WHEREAS the filed amendments had no impact on the overall rate level change of +11.7%; and

WHEREAS the amended proposal is filed in accordance with the Mandatory Simplified Filing
Guidelines; and

4 **WHEREAS** the Board is satisfied that the proposed rates are just and reasonable in the 5 circumstances, do not impair the solvency of the insurer, are not excessive in relation to the 6 financial circumstances of the insurer, and do not violate the **Automobile Insurance Act** or the 7 **Insurance Companies Act** or the respective regulations thereunder.

The revised rating program as amended February 23, 2024 from Aviva General Insurance
Company for its Interurban Vehicles category of automobile insurance is approved to be

14 effective no sooner than May 1, 2024 for new business and renewals.
