 a proceeding before the Board; and

WHEREAS in Order No. P.U. 29(2013) the Board found that the participation of Vale
Newfoundland and Labrador Limited ("Vale") was helpful to the Board in its consideration of
the Application and contributed to the Board's understanding of the issues and ordered that Vale
be awarded costs in an amount to be fixed by the Board; and

WHEREAS on December 9, 2013 Vale submitted a bill of costs in the amount of \$60,451.63 for
 the Board's consideration; and
