25 26 27 28	WHEREAS Newfoundland and Labrador Hydro ("Hydro") is a corporation continued and existing under the <i>Hydro Corporation Act</i> , is a public utility within the meaning of the <i>Act</i> , and is also subject to the provisions of the <i>EPCA</i> ; and
29 30 31	WHEREAS section 90 of the <i>Act</i> gives the Board the authority and discretion to award costs in a proceeding before the Board; and
32 33 34	WHEREAS in Order No P.U. 14(2015) the Board found that Vale Newfoundland & Labrador Limited ("Vale") was entitled to an award of costs; and
35 36 37	WHEREAS on June 1, 2015 Vale filed a cost submission with the Board for approval of costs in the amount of \$14,396.50 (exclusive of HST); and
38 39	WHEREAS in response to the Board's request for comments on the bill of costs, Hydro advised that it did not have any comments about the particulars of the costs sought; and

WHEREAS the Board has reviewed the bill of costs submitted by Vale and is satisfied that Vale's costs should be fixed in the amount of \$14,396.50 (exclusive of HST).
