22	WHEREAS Newfoundland and Labrador Hydro ("Hydro") is a corporation continued and
23	existing under the Hydro Corporation Act, is a public utility within the meaning of the Act, and
24	is also subject to the provisions of the <i>EPCA</i> ; and

26	WHEREAS section 90 of the Act gives the Board the authority and discretion to award costs in
27	a proceeding before the Board; and
28	
29	WHEREAS in Order No P.U. 35(2015) the Board found that Vale Newfoundland & Labrador
30	Limited ("Vale") was entitled to an award of costs; and

32	WHEREAS on December 22, 2015 Vale filed an application with the Board requesting approval
33	of its costs to intervene in the application in the amount of \$3,026.00 (exclusive of HST); and
34	
35	WHEREAS in response to the Board's request for comments on the bill of costs Hydro
36	requested that the Board exercise its discretion in determining the amount of costs to be awarded
37	to Vale: and

WHEREAS the Board has reviewed the bill of costs submitted by Vale and is satisfied Vale's costs should be fixed in the amount of \$3,026.00 (exclusive of HST).
