Re: Application by Nalcor Energy pursuant to Section 5.5(1) of the *Electrical Power Control Act*: Information Requests PUB-CIE-1 through PUB-CIE-13; our file no. 7550/004

Dear Ms. Blundon,

This is further to the above-mentioned Information Requests which we received on Friday, January 22, 2010 to which the Board asked for an answer by Thursday, January 28th at noon Newfoundland time.

Unfortunately, I am in meetings and away from my office as of Monday, January 25, 2010, with my return scheduled for January 28th in the morning.

But in any case, the nature and complexity of the questions posed by the Board are more than any party could answer in three and one-half working days.

Our intervention explicitly asked for an order, *inter alia*:

- "suspending Nalcor's application and setting aside for future examination the duty to consult and accommodate the Innu of Ekuanishit" pursuant to s. 27(1)(g) of the *Electrical Power Control Act*, 1994, S.N.L. 1994, c. E-5.1; and
- in any event, granting intervenor funding in the nature of advance costs pursuant to s. 90 of the *Public Utilities Act*, R.S.N.L. 1990, c. P-47, and as provided for in *British Columbia* (*Minister of Forests*) v. Okanagan Indian Band, [2003] 3 S.C.R. 371.

We would be grateful if the Board could indicate when and how it anticipates addressing these issues, which will determine our approach to the Information Requests.

We would also point out that the Board's powers under s. 27(1)(g) of the *Electrical Power Control Act*, 1994, clearly take precedence over the 120-day schedule provided for in s. 7 of the *Water Management Regulations*, N.L.R. 4/09.
