

Island Supply Notes For October 12, 2025

- A As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
- As of 2000 hours, September 13, 2025, Holyrood Unit 2 unavailable due to forced extension to planned outage 115 MW (170 MW).
- E As of 1312 hours, September 17, 2025, St. Anthony Diesel Plant unavailable due to a planned outage (9.7 MW).
- F As of 1829 hours, October 08, 2025, Labrador Island Link available at 450 MW due to planned derating (700 MW) Monopole.
- **G** As of 1502 hours, October 09, 2025, Holyrood Unit 1 available at 100 MW due to forced derating (170 MW).

Island Supply Notes For October 13, 2025

Notes: 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.
