

Island Supply Notes For October 16, 2025

- A As of 0800 hours, March 30, 2025, Holyrood Unit 3 unavailable due to planned outage 130 MW (150 MW).
 - As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 1 unavailable due to planned outage (76.5 MW).
- As of 0823 hours, March 31, 2025, Bay d'Espoir Unit 2 unavailable due to planned outage (76.5 MW).
- As of 1312 hours, September 17, 2025, St. Anthony Diesel Plant unavailable due to a planned outage (9.7 MW).
- As of 1502 hours, October 09, 2025, Holyrood Unit 1 available at 100 MW due to forced derating (170 MW).
- At 0730 hours, October 16, 2025, Holyrood Gas Turbine unavailable due to planned outage (123.5 MW).
- At 1400 hours, October 16, 2025, Cat Arm Unit 2 available (67 MW).
- H At 2143 hours, October 16, 2025, Holyrood Unit 2 available at 140 MW due to planned derating (170 MW)

Island Supply Notes For October 17, 2025

Notes: 1. Generation outages for running and corrective maintenance are included. These are not unusual for power system operations. They generally do not impact customer supply. Hydro schedules outages to system equipment whenever possible to coincide with periods when customer demands are low and sufficient supply reserves are available. However, from time to time equipment outages are necessary and reserves may be impacted.

- 4. Gross output from all Island sources (including Note 3).
- 5. NLH Island Power Purchases include: ML Imports, Exploits Generation, Rattle Brook, Star Lake, Wind Generation and capacity assistance (when applicable).
