# Re: Newfoundland and Labrador Hydro - Reliability and Resource Adequacy Study Review - Record and Proceeding

This further to our letter of December 4, 2019 and the Board's Notice dated December 11, 2019 inviting participants in the Board's review of Newfoundland and Labrador Hydro's Reliability and Resource Adequacy Study.

The following parties have been granted Intervenor Status to participate in this review:
