12	Α.	This Request for Information relates to the Electrification, Conservation and Demand
13		Management Plan: 2021-2025 (the "2021 Plan") developed in partnership by Newfoundland and
14		Labrador Hydro and Newfoundland Power ("Hydro" or, collectively, the "Utilities"). Accordingly,
15		the response reflects collaboration between the Utilities.
16		a) "At-cash rebates" will be provided to utility customers, or household members of utility
17		customers, by providing proof of residency to the dealership at the time of purchasing or
18		leasing a qualifying electric vehicle ("EV"). <sup>1</sup> If an individual is not a permanent resident of
19		Newfoundland and Labrador, they will not qualify for an incentive. The individual will also
20		be required to sign a form confirming their address and that the premises has an active
21		electricity service. If it is determined at a later time that the individual does not live in a
22		household that has electricity service provided by either Newfoundland Power Inc.

1 2		("Newfoundland Power") or Newfoundland and Labrador Hydro ("Hydro"), the dealership would not be reimbursed for the incentive paid to the individual. <sup>2</sup>
3 4 5		Hydro will provide incentives for individuals who live in a household that has an active electricity account in its service territory on the Island Interconnected or Labrador Interconnected Systems. Newfoundland Power will be responsible for providing incentives
6		for individuals in its service territory.
7 8 9	b)	Used vehicles are eligible for rebates only if the vehicle has not been previously rebated through the Residential EV and Charger Program. Rebate amounts vary based on the age of the vehicle.
10 11		There are no limits associated with the purchase cost of the vehicle or the number of EV incentives available per household.
12 13		Exact program details will be finalized upon approval of Hydro's application. See PUB-NLH-002, Attachment 1 for draft program eligibility requirements.

#### **Draft Residential Electric Vehicle Eligibility Requirements:**

- You have an active electricity account with Newfoundland Power or Newfoundland and Labrador Hydro.<sup>1</sup>
- You are a permanent resident of Newfoundland and Labrador.

#### *New\* Electric Vehicle Eligibility:*

- Must be included on the approved list of all-electric and plug-in hybrid electric vehicle models available at TakeChargeNL.ca, and purchased on or after *<insert program start date>*.
- Must be purchased from a participating dealership to receive an instant rebate. A list of participating dealerships is available at TakeChargeNL.ca. Vehicles purchased out-of-province must be purchased from a licensed vehicle dealership located in Canada and the application form submitted online or by mail to your electricity utility.
- Must be registered\*\* in Newfoundland and Labrador.

Rebate amounts vary depending on whether the vehicle is purchased, financed or leased. Leased vehicles must be for a period greater than 48 months to qualify for a rebate. Rebate amounts are indicated in Table 1 below.

#### Pre-Owned All-Electric Vehicle Eligibility:

• In addition to the requirements listed above for new electric vehicles, to be eligible for a rebate on a pre-owned all-electric vehicle, the vehicle must not have previously received a rebate through the takeCHARGE Electric Vehicle Rebate Program.

The rebate applied to purchased or financed pre-owned all-electric vehicles is based on the age of the vehicle. Rebate amounts are indicated in Table 2 below.

## **Draft Commercial Electric Vehicle Eligibility Requirements:**

 You must have an active commercial electricity account with Newfoundland Power or Newfoundland and Labrador Hydro.<sup>2</sup>

## *New\* Electric Vehicle Eligibility:*

- Must be included on the approved list of all-electric and plug-in hybrid electric vehicle models available at TakeChargeNL.ca, and purchased on or after *<insert program start date>*.
- Must be purchased from a participating dealership to receive an instant rebate. A list of participating dealerships is available at TakeChargeNL.ca. Vehicles purchased out-of-province must be purchased from a Canadian Automobile Dealership and the application form submitted online or by mail to your electricity utility.
- Must be registered\*\* in Newfoundland and Labrador.

The rebate applied to purchased or financed pre-owned all-electric vehicles is based on the age of the vehicle. Rebate amounts are indicated in Table 4 below.

#### **Draft Residential Electric Vehicle Charger Eligibility Requirements:**

To be eligible for the rebate, a customer must:

- Have an active electricity account with Newfoundland Power or Newfoundland and Labrador Hydro.<sup>3</sup>
- Must be the homeowner and the home must be intended as a permanent residence. (Renters must have written consent from the homeowner).
- Own or be leasing a battery electric vehicle ("BEV") or plug-in hybrid electric vehicle ("PHEV").
- On the list of approved makes and models takechargenl.ca.
- Agree to connect the charger to the internet via a wired, wireless, or cellular connection.
- Installed by a certified electrician. Permit must be submitted with application.

## Draft Commercial EV Charger Eligibility Requirements:

- You must have a general service account or own a multi-unit residential building containing at least three (3) units.<sup>4</sup>
- On the list of approved makes and models at takechargenl.ca.
- Installed by a certified electrician. Permit must be submitted with application.
- Have dedicated parking for users if charger is to be publicly accessible.
- Agree to connect the charger to the internet via a wired, wireless, or cellular connection.
