**Re: Newfoundland and Labrador Hydro - 2021 Capital Budget Supplemental Application
Approval of the Construction of Phase 1 of Hydro's Long-term Supply Plan for
Southern Labrador – Review Schedule Suspended**

The Board is in receipt of Hydro's correspondence dated November 10, 2021 requesting that the review schedule for its proposed project for the long-term supply for southern Labrador be paused to allow further stakeholder consultation and engagement. The Board agrees that the review schedule should be suspended to allow Hydro to further engage with those that have provided comments to the Board as well as to ensure that all parties that may have an interest in this project have been notified and consulted. The Board requests that Hydro provide its update on these consultations and its proposal by December 13, 2021. In this update, the Board also requests that Hydro confirm whether this suspension will impact service in Charlottetown and provide its plan to address the impacts, if any.
