Re: Newfoundland Power Inc. – 2022 Capital Budget Application – Consumer Advocate's Requests for Information CA-NP-117 to CA-NP-175 and Request to Amend Schedule – To Parties – Additional RFIs Permitted

This is further to the Board's letter to the parties of August 25, 2021 requesting comments on whether some or all of the Consumer Advocate's Requests for Information (RFIs) CA-NP-117 to CA-NP-175 filed on August 20, 2021 should be permitted and the Consumer Advocate's request to amend the schedule to enable Newfoundland Power to provide responses to the RFIs.


Newfoundland Power advised on August 27, 2021 that, in its view, the Board has the authority to issue additional RFIs and that it is agreeable to responding to the additional RFIs filed by the Consumer Advocate. In relation to the amendment of the schedule Newfoundland Power advised that it would require approximately two weeks to respond to the RFIs. Hydro did not have any comments.

The Board will permit the filing of the additional RFIs by the Consumer Advocate and sets Tuesday, September 14, 2021 as the filing date for responses.

Board counsel will contact the parties early next week to discuss further changes to the schedule as required.
