Re: Newfoundland Power Inc. - 2022-2023 General Rate Application - To Parties - Newfoundland Power's Revised Witness List and Rebuttal Evidence

The Board is in receipt of Newfoundland Power's Revised Witness List and Rebuttal Evidence filed on November 9, 2021.

The Board notes that the scheduled date for filing expert reports and pre-filed evidence was September 28, 2021 and that Newfoundland Power did not file expert report or pre-filed evidence by Wiclif Ma (Korn Ferry) at that time. A request from Newfoundland Power for an amendment to the schedule to allow evidence to be filed will need to be submitted to the Board. The request should outline the nature of the evidence to be provided by the proposed witness, its relevance to the General Rate Application and an explanation for the evidence not being filed in accordance with the established schedule. The Consumer Advocate and Newfoundland and Labrador Hydro will be provided the opportunity to file their comments on the request.

The request to allow for additional evidence to be filed must be submitted to the Board by Friday, November 12, 2021. Comments from the parties are to be filed by Monday, November 15, 2021.
