FOR THE APPROVAL OF AN AMENDMENT OF A
MOTOR CARRIER CERTIFICATE.**

WHEREAS by letter, dated and received by the Board on June 2, 2003, The Town of Bay L'Argent requested the Board of Commissioners of Public Utilities amend Motor Carrier Certificate No. 3585 to include the following service:

IRREGULAR ROUTE SPECIALTY AMBULANCE SERVICE for the transportation of persons requiring medical attention or under medical care upon the request of a medical doctor or registered nurse from Petite Forte to any hospital, nursing home, first aid station or home for senior citizens and upon the specific request of a medical doctor, registered nurse or a police officer between any two points within the province of Newfoundland and Labrador.

WHEREAS the community of Petite Forte is within the geographic scope of the operating authority issued to the applicant, and

WHEREAS the community was, at the time of issuance of the certificate to the applicant, inaccessible by road, and

WHEREAS the community has been accessible by road since 1992, and

WHEREAS the Board is of the opinion that the addition of the community of Petite Forte to the operating authority issued to the applicant is in the public interest, and

WHEREAS the Board of Commissioners of Public Utilities is of the opinion that a public hearing is not necessary, and that the applicant has met the requirements of the Motor Carrier Act and Regulations.

IT IS THEREFORE ORDERED THAT:

The operating authority of the applicant be amended to provide service to designated highway route numbers covered by the communities currently authorized in the certificate and including the community of Petite Forte, that is:

IRREGULAR ROUTE SPECIALTY AMBULANCE SERVICE for the transportation of persons requiring medical attention or under medical care upon the request of a medical doctor or registered nurse from all points on or accessed by Highway 210, between and including the Junction of Highway Route # 210 with 211 including Highway Route # 211 and Highway Route # 210 with the access road to Rushoon, and including the access Road to Rushoon to any hospital, nursing home, first aid station or home for senior citizens and upon the specific request of a medical doctor, registered nurse or a police officer between any two points within the province of Newfoundland and Labrador.
