1 **IN THE MATTER OF** the *Motor Carrier Act*,  
2 Chapter M-19, RSNL 1990 as amended (the “*Act*”),  
3 and its subordinate regulations;

5 **AND**

7 **IN THE MATTER OF** the application of  
8 Mrs. Margaret Clowe (the “Applicant”)  
9 for the approval of an amendment of  
10 Motor Carrier Certificate No. 4006.

11  
12  
13 **WHEREAS** on February 21, 2006 the Board received an application from the Applicant completed  
14 in accordance with the said Act and Regulations requesting approval of an amendment to Motor  
15 Carrier Certificate No. 4006 to add the following service:

16  
17 IRREGULAR SPECIALTY AMBULANCE SERVICE for the transportation of  
18 persons requiring medical attention or under medical care upon the request of a  
19 medical doctor, registered nurse or a police officer from any point located on  
20 Highway Route No. 10, or accessed thereby, between and including Chance Cove  
21 Provincial Park and Aquaforte to any hospital, nursing home, first aid station or  
22 home for senior citizens within the Province of Newfoundland and Labrador, and  
23 upon the specific request of a medical doctor, registered nurse or a police officer  
24 between any two points within the province of Newfoundland and Labrador; and

26 **WHEREAS** notice of the application was published by the Applicant in the March 10, 2006 edition  
27 of The Newfoundland and Labrador Gazette; and

28  
29 **WHEREAS** on March 29, 2006 the Board received an objection and a request for a public hearing  
30 on behalf of Emergency Medical Services (2006) Inc. (the “Objector”); and

31  
32 **WHEREAS** the Board determined that a public hearing was necessary and notified the parties  
33 accordingly; and

34  
35 **WHEREAS** at the request of the Applicant the matter was not set down for a public hearing pending  
36 the resolution of discussions by the Applicant with the Department of Health and Community  
37 Services; and

1 **WHEREAS** on April 11, 2007 the Board was advised by the Objector that it had ceased providing  
2 ambulance services as authorized in its Motor Carrier Certificate; and

3  
4 **WHEREAS** on July 16, 2007 the Objector notified the Board that it was withdrawing its  
5 objection to the granting of the application of Mrs. Clowe; and

6  
7 **WHEREAS** there being no objection to the application a public hearing will not be held and the  
8 application will be approved.

9  
10 **IT IS THEREFORE ORDERED THAT:**

12 1. The application of Mrs. Margaret Clowe to amend Motor Carrier Certificate No. 4006 to add,

13  
14 IRREGULAR SPECIALTY AMBULANCE SERVICE for the transportation of persons  
15 requiring medical attention or under medical care upon the request of a medical doctor,  
16 registered nurse or a police officer from any point located on Highway Route No. 10, or  
17 accessed thereby, between and including Chance Cove Provincial Park and Aquaforte to any  
18 hospital, nursing home, first aid station or home for senior citizens within the Province of  
19 Newfoundland and Labrador, and upon the specific request of a medical doctor, registered  
20 nurse or a police officer between any two points within the province of Newfoundland and  
21 Labrador;

23 pursuant to s. 6(1) of the *Act* is approved.
